I, \_\_\_\_\_, hereby grant The Arton Company ("Arton" or "Licensee") an irrevocable license to use my enclosed artwork now or at any time in the future, throughout the world in any manner it so chooses and in any medium now known or later developed. This includes, the right to modify the artwork as necessary in Arton's sole discretion. This also includes, without limitation, use on Arton products and merchandise, and any other promotional material it wishes. I acknowledge that Arton is under no obligation to use my artwork. By signing this form, I agree that Arton will credit my artwork, first name, and age of artist when he/she created the artwork. Such credit will appear in a form similar to the following, which such form may be changed by Arton in its sole discretion: **"FIRST NAME ARTIST, AGE OF ARTIST WHEN HE/SHE CREATED ARTWORK."** I agree that there are to be no fees, commissions or royalties paid to me for the use of the artwork. I acknowledge and agree that I am the owner of the enclosed artwork and that I have the exclusive right and authority to grant the licenses granted herein. In signing, the artist will agree to have the artwork registered with the U.S. Copyright Office in his/her name; Arton will prepare all documents required to do so and the licensee agrees to execute all necessary documents and bear all expenses associated with registration. Once registered and licensed, the artwork may then be printed on merchandise and sold in order to raise money, a percentage of which, will, in turn be donated directly to the public school art program of Arton's choice. In addition, if the donating party is a minor, 5% of net profits from merchandise exhibiting this artwork will be put into a scholarship fund for the participating artist set up in his/her name. All art will be returned within 1 year of having been received.
